ARTICLES OF ORGANIZATION
OF

ARTICLE VI-Regulations

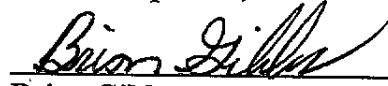
The power to adopt, alter, amend, or repeal the Regulations of the Company is vested in the members of the Company as provided in the Regulations.

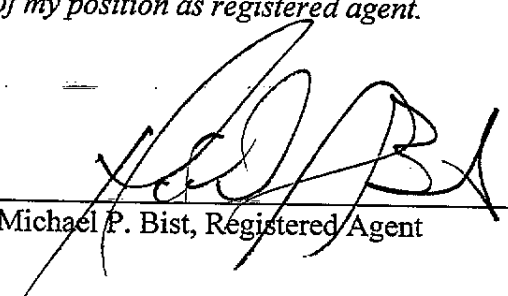
