### ARTICLE OF AMENDMENT TO ARTICLES OF ORGANIZATION FOR SCHOOL DEVELOPMENT II LLC A FLORIDA LIMITED LIABILITY COMPANY

### THIS IS TO CERTIFY THAT:

FIRST: This Article amends the Articles of Organization of SCHOOL DEVELOPMENT II LLC, a Florida limited liability company ("Company").

SECOND: The Articles of Organization were filed with the Florida Department of State on April 22, 2002.

THIRD: The Articles of Organization were previously silent as to the "Purpose" of the Company. The Articles of Organization, as amended, shall provide as follows:
