The name of the limited liability company is BHC PARTNERS, LLC.

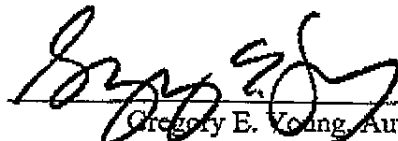
