

ARTICLES OF ORGANIZATION

OF

R & S AMOS, L.L.C.

ARTICLE I
NAME

The name of this Limited Liability Company is R & S AMOS, L.L.C.

ARTICLE II
DURATION

This Limited Liability company shall have a perpetual existence commencing on the date these Articles are filed with the Secretary of State for the State of Florida, unless sooner terminated as provided herein.

ARTICLE III
PURPOSE

This Limited Liability Company is created for the purpose of transacting all lawful business for which limited liability companies may be organized under the Florida Limited Liability Company Act as agreed upon by the members.

ARTICLE IV
PLACE OF BUSINESS AND REGISTERED AGENT

The principal place of business of this Limited Liability Company shall be 3513 Indian Trail, Eustis, Florida 32726, or such other place or places as the members from time to time may determine.

The mailing address of this Limited Liability Company shall be Post Office Box 350070, Grand Island, Florida 32735.

The initial Registered Agent of this Limited Liability Company shall be Ronald L. Amos, 3513 Indian Trail, Eustis, Florida 32726.

**ARTICLE V
CONTRIBUTIONS TO CAPITAL**

The initial capital of this Limited Liability Company shall be \$100.00 contributed by member RONALD L. AMOS and \$100.00 contributed by member SHIRLEY J. AMOS. The value of such contributions by members, as agreed by the members, is \$200.00.

**ARTICLE VI
MANAGEMENT OF THE BUSINESS**

This Limited Liability Company shall be a manager-managed company. The initial manager shall be RONALD L. AMOS whose address is 3513 Indian Trail, Eustis, Florida 32726. Such manager shall continue to manage this Limited Liability Company until a qualified successor is duly elected by a majority of members. Such manager of this Limited Liability Company shall have the power to adopt, alter, demand, or repeal the regulations of this Limited Liability Company.

**ARTICLE VII
ADDITIONAL MEMBERS**

The initial members of this Limited Liability Company may admit additional members only according to the terms and conditions of a unanimous vote of the members.

**ARTICLE VIII
TRANSFERABILITY OF MEMBER'S INTEREST**

A member's interest in this Company may be transferred only with the unanimous written consent of all the remaining members if the transferee intends to become a member. Without this consent, the transferee shall not be entitled to become a member or to participate in the management of the Company, but shall be entitled only to distributions to which the transferor otherwise would be entitled.


ARTICLE IX

These Articles, except for the vested rights of the members, may be amended from time to time by a two-thirds (2/3) majority in interest of the members, and the amendments shall be filed, duly signed by all members of the Company, with the Florida Department of State. All members agree to abide by the majority decision and agree to sign the amendments for the purpose of filing with the Florida Department of State.

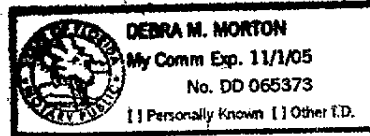

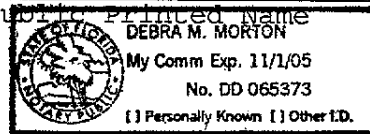

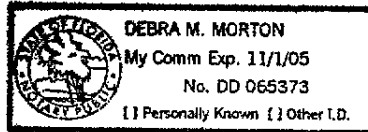
