ARTICLES OF ORGANIZATION OF GREEN WAY PROPERTIES, LLC

The undersigned, David Kelly, a natural person competent to contract and member of this limited liability company, hereby presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 608, Florida Statutes.

ARTICLE I

The name of the limited liability company is:

GREEN WAY PROPERTIES, LLC

This limited liability company is referred to in these articles of organization the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing and street address of the principal office of the Company is 125 W. Romana Street, Suite 800, Pensacola, Florida 32501.

ARTICLE III - PURPOSES AND POWERS

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and may exercise all powers and rights which a limited liability company may exercise under the Florida Limited Liability Company Act.

A member may not sell or otherwise transfer his interest in the Company, whether represented by membership units, certificates, or a percentage interest in the Company, until the member has complied with the restrictions, including a right of first refusal, contained in the Operating Agreement.
