ARTICLE I

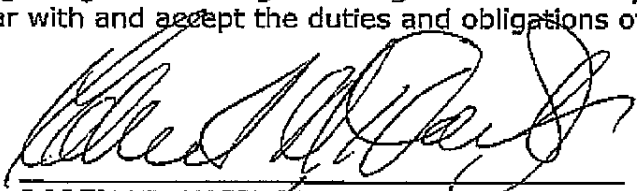
