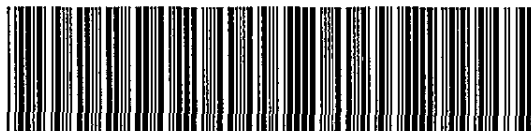


(3) Items sent by certified or registered mail shall be deemed delivered five (5) days after deposit in the United States mail, postage prepaid.
