CONTINUATION AFTER INVOLUNTARY TERMINATION

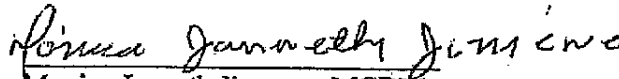

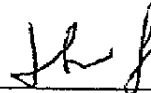

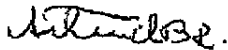
