
ARTICLE XIII. DISSOLUTION.

- (b) when the company has fewer than one (1) member.



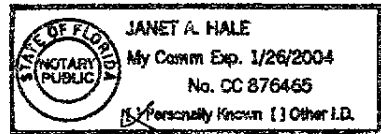
