ARTICLE ONE NATURE OF BUSINESS

This limited liability company may engage in any real estate business permitted under the laws of the United States of America and the laws of the State of Florida. ARTICLE FOUR CONTRIBUTIONS TO CAPITAL

The initial capital of this limited liability company shall consist of the sum of One Thousand and no/100 (\$1,000.00) dollars which will be contributed by the members.
