pursuant to the laws of the State of Florida.

ARTICLE I  
NAME

The name of this limited liability company shall be S<sup>4</sup>, LLC,  
hereinafter referred to as the limited liability company.

ARTICLE II  
DURATION

This limited liability company is to exist perpetually.

ARTICLE III  
PURPOSES

The nature of the business to be conducted and promoted by  
the Limited Liability Company, and the purposes of the limited  
liability company are to engage in the following activities:

1. To lease or purchase real property with or without  
improvements located thereon and to mortgage, pledge, lease,  
construct improvements upon and otherwise deal with such  
property.
2. To own and operate a business or businesses;
3. To exercise all powers enumerated in the Limited Li-  
ability Company Act of Florida necessary or convenient to the  
conduct, promotion or attainment of the business or purposes  
otherwise set forth herein.

ARTICLE IV

ARTICLE VI  
RESTRICTIONS ON MEMBERSHIP

This limited liability company shall have the right to admit *new members* by unanimous written consent of all the existing members. Contributions required of new members shall be determined by the unanimous vote of all the existing members at the time of admission of the new members to this limited liability company.

ARTICLE VII  
CONTINUATION OF BUSINESS

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in this limited liability company, the remaining members shall have the right to continue the business of this limited liability company.

ARTICLE VIII  
MANAGEMENT

This limited liability company shall be managed by the members in accordance with an operating agreement adopted by its members for the management of its business affairs. The operating agreement may contain any provisions for the regulation and management of its affairs not inconsistent with law or these articles of organization. Execution of deeds, mortgages, leases for more than one year, and promissory notes and other obligations for more than \$2500 shall require the signature of all members in order to bind the limited liability company.

ARTICLE IX  
PROFITS AND LOSSES

(a) Sharing of Profits. The members shall share equally the profits arising from the operation of the limited liability company business that remain after the payment of the expenses of conducting the business or in such proportion that may be unanimously agreed upon, in writing, by the members.

(b) Losses. All losses that occur in the operation of the limited liability company business shall be paid out of the capital of the limited liability company and the undistributed profits of the limited liability company. The tax consequences of those losses shall be shared equally by the members.

(c) The members shall share all distributions equally to the extent of undistributed profits. Distributions from capital shall be in proportion to contributions of capital unless otherwise agreed by all members.

The said members hereby certify that the foregoing constitutes the Articles of Organization of S<sup>4</sup>, LLC.

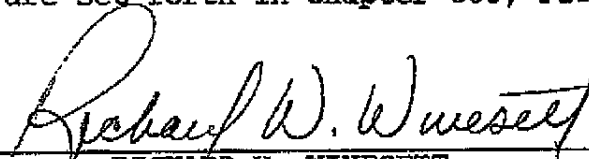
