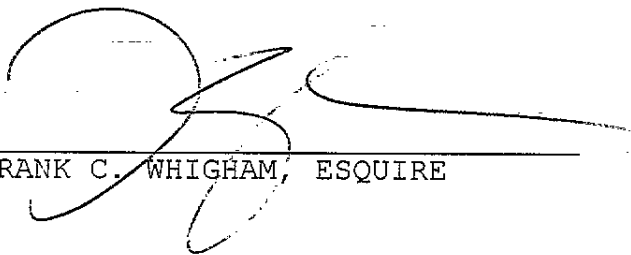

ARTICLES OF ORGANIZATION
OF
PRYMUS JENKINS, LLC

I, the undersigned as organizer and only member of a limited liability company, under the Florida Limited Liability Company Act, adopt the following Articles of Organization for such limited liability company:

ARTICLE I
NAME

The name of the limited liability company shall be **PRYMUS JENKINS, LLC**.

ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office of this limited liability company is **3331 Hughey St., Sanford, FL 32771**, and the mailing address shall be the same. 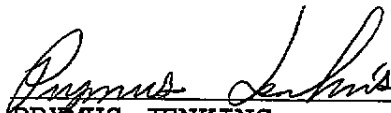

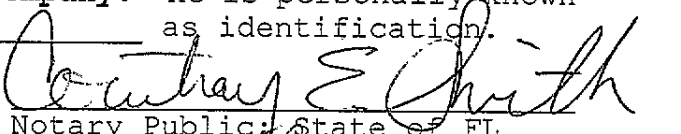
