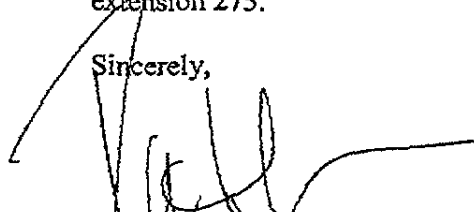

**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF ORGANIZATION OF  
COAST POINCIANA, P.L.**

Pursuant to Sections 607.1006 and 621.13 of the Florida Statutes, the undersigned company (the "Professional Company"), a professional limited liability company organized and existing under and by virtue of the laws of the State of Florida, adopts the following Articles of Amendment to Articles of Organization.

1. **Article IV Management.** The managers were incorrectly named in the initial Articles of Organization, which stated: The professional Limited Liability company is to be managed by members Adam Diasti, D.D.S. and Laila H. Rizvi, D.M.D. and the address of the Managing Members is 2502 Rocky Point Drive, Suite 1000, Tampa, FL 33607.
2. **Amendment Adopted.** The amendment adopted provides for a change of the name of the managing member, Article IV.
3. **Text of Amendment.** Article IV of the Articles of Organization is hereby amended by deleting such Article in its entirety and substituting in lieu of such Article the following new Article IV which reads as follows:

**ARTICLE IV  
MANAGEMENT**

The professional limited liability company is to be managed by members ~~Coast Poinciana, P.A.~~ Florida, P.A. and Laila H. Rizvi, D.M.D. and the address of the managing members is 2502 Rocky Point Drive, Suite 1000, Tampa, FL 33607.

4. **Authorization of Amendment.** The foregoing amendment was adopted on September 1, 2002, by written consent of the sole director and sole shareholder of the Professional Company duly adopted resolutions proposing and declaring the above amendment to the Articles of Organization of the Professional Company.
