ARTICLES OF ORGANIZATION OF DESTIN HARBOR CHARTERS, L.L.C.

The principal office of this limited liability company shall be located at 101 Montero Way, Destin, Florida 32541.



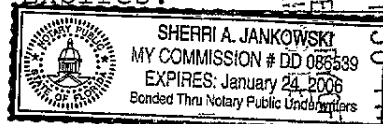
