**ARTICLES OF ORGANIZATION  
OF

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida, sets forth the following:

**ARTICLE I - NAME**

The name of this limited liability company is **POPE & MOORE, LLC** (the "Company").

The Company is to be managed by an operating manager or managers, and is therefore a manager-managed limited liability company.
