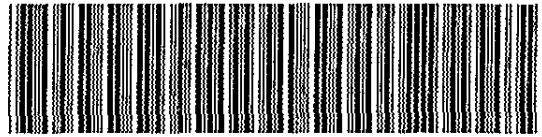



SECOND: The following amendment to the Articles of Organization was adopted by the limited liability company:


For the purpose of changing the name of the limited liability company, Article I is hereby amended as follows:
