2. Duration. The latest date upon which the limited liability company is to dissolve is January 1, 2099.

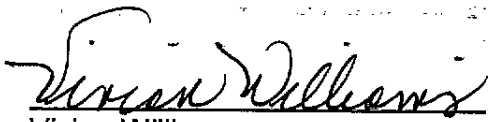
