**ARTICLE I**

**Name**


## ARTICLE VIII

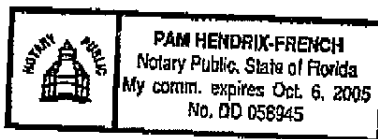
