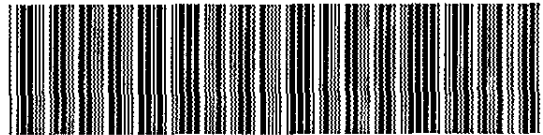

FOURTH: The Company is hereby dissolved because all remaining members have voted to dissolve the Company in accordance with Section 608.441(C), Fla. Stat.

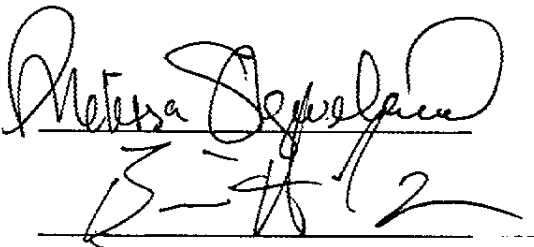
