The mailing address and the street address of the principal office of this limited liability company is 5121 Ehrlich Road, Suite 112-B, Tampa, Florida 33624.

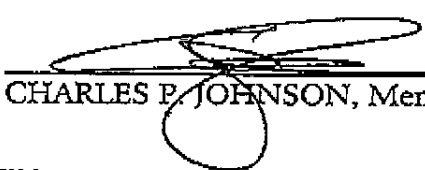
ARTICLE 3
