**ARTICLE OF ORGANIZATION
OF
Romc5, L.L.C.**

Name of the Limited Liability Company**

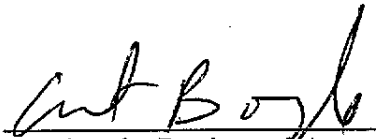
The name of the limited liability company shall be Romc5, L.L.C.

Period of Duration

The limited liability company's existence shall commence upon the acceptance of these Articles of Organization by the Secretary of State of Florida for filing and shall continue for a period of 2 years, unless sooner dissolved pursuant to the terms of its operating agreement, or as otherwise provided by law.

ARTICLE V
Written Operating Agreement

The actions of a member, manager, or any other person acting in any capacity other than as a manager of the limited liability company in accordance with the terms of its operating agreement shall not bind the limited liability company.
