**ARTICLES OF ORGANIZATION

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

**ARTICLE I - NAME**

The name of this Limited Liability Company is PINE MEADOWS FARM, LLC.

**ARTICLE II - MAILING ADDRESS**

The mailing address and street address of the principal office of PINE MEADOWS FARM, LLC, 2180 Twilight Trail, Chuluota, Florida 32766.

**ARTICLE III - DURATION**

The period of duration for PINE MEADOWS FARM, LLC shall be perpetual from the date of filing these Articles with the Department of the State, except for the limitations set out in Florida Statutes Section 608.441.

**ARTICLE IV - REGISTERED AGENT & OFFICE**

The name of the initial registered agent is LISA ANNE SENECALE. The street address of the initial registered agent is 2180 Twilight Trail, Chuluota, Florida 32766.

**ARTICLE V - ADDITIONAL MEMBERS**

Additional members to the Company may be admitted, but only if all the current members agree to the admission of the additional members and to the terms of admission.

**ARTICLE VI - TERMINATION OF MEMBERSHIP**

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in PINE MEADOWS FARM, LLC, the remaining members may, by unanimous agreement, continue the business of PINE MEADOWS FARM, LLC.

ARTICLE VII - MANAGEMENT

PINE MEADOWS FARM, LLC is to be managed by a manager and the name and address of the individual who will serve as the manager is:

This initial manager shall serve until a successor manager(s) is qualified and elected as prescribed by and provided in the regulations of the Company. The manager shall also hold the office and have the responsibilities accorded to him/her by the members set out in the regulations of the Company.

The members shall have the power to adopt, alter, amend, or repeal regulations of PINE MEADOWS FARM, LLC.
