INSIDE PROPERTY MANAGEMENT, L.L.C.

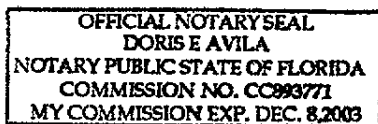


