The mailing and street address of the Company's principal office is 1002 62<sup>nd</sup> Street S., Gulfport, Florida 33707.

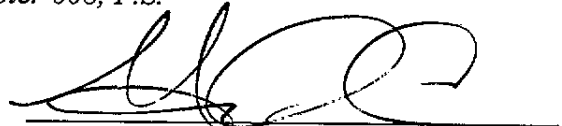
**ARTICLE III**
