

ARTICLES OF ORGANIZATION

OF

a Florida Limited Liability Company

- The name of this limited liability company is PARK PROPERTIES PALM BEACH, LLC 1. (the "Company").
- 2. The Company is being formed for the following purposes:
 - To engage in any and all lawful business or activity permitted under the laws of the a. United States and the State of Florida.
 - To generally have and exercise all powers, rights and privileges necessary and b. incident to carrying out properly the objects herein mentioned.
 - To do anything and everything necessary, suitable, convenient or proper for the c. accomplishment of any of the purposes or the attainment of any or all of the objects hereinbefore enumerated or incidental to the purposes and powers of the company or which at any time appear conducive thereto or expedient.

This Company shall have all of the powers enumerated in the Florida Limited Liability Company Act, as amended from time to time.

The Company shall only admit additional members with the unanimous written consent of 5. the Company's Members.

- 6. The Company shall have perpetual existence unless sooner dissolved in accordance with the Florida Limited Liability Company Act, as amended from time to time. Accordingly, the members may continue the Company and the business of the Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member.

Said indemnification shall include, but not be limited to, the expenses, including the cost of any judgments, fines, settlements and counsel's fees, actually and necessarily paid or incurred in connection with any action, suit or proceedings, whether civil, criminal, administrative or investigative, and any appeals thereof, to which any such person or her legal representative may be made a party or may be threatened to be made a party, by reason of her being or having been an officer, employee or agent as herein provided. The foregoing right of indemnification shall not be exclusive of any other rights to which any officer, employee or agent may be entitled as a matter of law or which she may be lawfully granted.
