ARTICLE II – ADDRESS

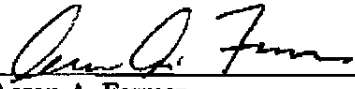

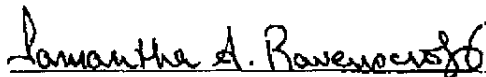
ARTICLE IV - DURATION
