Otherwise, the terms and conditions of all documents to be executed on behalf of the Company shall be determined by any of the Members or by the Managing Member, and the execution and delivery of any such document or instrument executed by a Member or the Managing Member shall constitute conclusive evidence that the terms and conditions contained in said documents or instruments have been approved by the Company.
