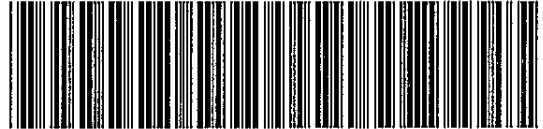



shall be void unless authorized in writing by all Members of the Company, unless such interest is a lease for a term of years not to exceed five (5) years in total including all renewal options.

Otherwise, the terms and conditions of all documents to be executed on behalf of the Company shall be determined by any of the Members or by the Managers, and the execution and delivery of any such document or instrument executed by a Member or a Manager shall constitute conclusive evidence that the terms and conditions contained in said documents or instruments have been approved by the Company.


