**ARTICLE I - Name**

The name of the Limited Liability Company is **SALERNO VILLAGE SHOPPING CENTER, LLC** (the "Company").

**ARTICLE II - Address**

The Manager shall be elected annually by the members in the manner prescribed by and provided for in the Regulations of the Company. The Manager shall also have responsibilities accorded to him by the members and as set forth in the Regulations of the Company. 
