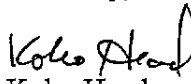

**ARTICLES OF ORGANIZATION  
OF

**ARTICLE I**

**NAME**

The name of the limited liability company is Eagle Capital, LLC ("Company").

**ARTICLE II**

**PRINCIPAL PLACE OF BUSINESS**

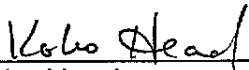
