**ARTICLES OF ORGANIZATION**

The undersigned, acting as the members of a limited liability company under the Florida Limited Liability Company Act as set forth in Chapter 608 of the Florida Statutes, does hereby adopt the following Articles of Organization for LA HACIENDA WEST PALM BEACH, LLC (the "Company"):

**ARTICLE I**

**NAME**

The rights accruing to any person under the foregoing provision shall not exclude any other right to which he/she may be lawfully entitled, nor shall anything therein contain or restrict the right of the Company to indemnify or reimburse such person in any proper case even though not specifically provided for herein.

The undersigned, being the original members of the Company, hereby certify that the foregoing constitutes the proposed Articles of Organization of LA HACIENDA WEST PALM BEACH, LLC.


