These Articles of Organization of KELLY LANDS LIMITED, L.L.C., a Florida limited liability company (the "Company"), dated as of the 6<sup>th</sup> day of May, 2002, are being duly executed and filed by John P. Kelly, the organizer, authorized to form a limited liability company under the Florida Limited Liability Company Act (Chapter 608, Florida Statutes) (the "Florida Act").

**FIRST:** The name of the limited liability company is KELLY LANDS LIMITED, L.L.C.

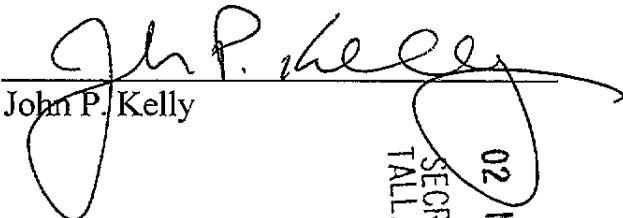

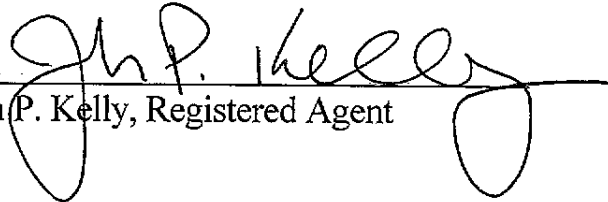
Pursuant to Section 48.091 and Section 608.415 of the Florida Statutes, the following is submitted:
