The mailing address and street address of the principal office of the Company is 55 Alhambra Plaza, 7th Floor, Coral Gables, Florida 33134.

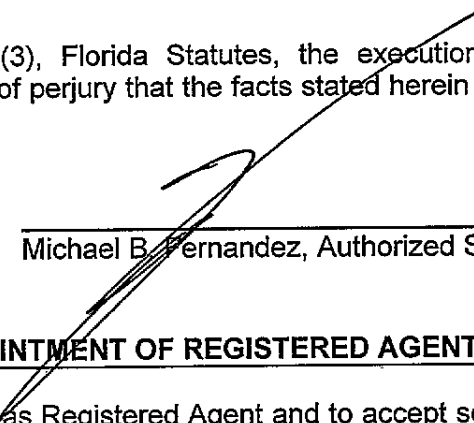
ARTICLE III - Registered Agent and Office
