## ARTICLES OF ORGANIZATION

OF

TUSCAWILLA 54<sup>TH</sup>, LLC

1. **NAME.** The name of this limited liability company is TUSCAWILLA 54<sup>th</sup>, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.




