## ARTICLES OF ORGANIZATION

#### FOR

# LAKESIDE OFFICE CENTER, L.L.C. A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, desiring to form a limited liability company under and pursuant to Fielda Statute 608 entitled the Florida Limited Liability Company Act (the "Act"), do hereby adopt the following Articles of Organization for such Company:

1. Name. The name of this Company shall be:

- 2. Duration/Continuation. This Company's existence shall terminate on December 31, 2030, unless terminated by the unanimous written agreement of all Members or by the death, retirement resignation, expulsion, bankruptcy or dissolution of a Member or upon the occurrence of any other event which terminates the continued membership of a Member, unless the business of the Company is continued by the consent of all the remaining Members, or by amendment of these Articles of Organization providing for the continued existence of the Company subsequent to the foregoing events.
- Principal Office and Mailing Address. The mailing address is c/o Weston Professional & Medical Executive Offices, Inc., 2101 Corporate Boulevard, N.W., Suite 300, Boca Raton, Florida 33431.
- Registered Agent and Office. The name and street address of the initial registered agent and office for this Company is as follows: Weston Professional & Medical Executive Offices. Inc., 2101 Corporate Boulevard, N.W., Suite 300, Boca Raton, Florida 33431.
- 5. Admission of Additional Members; and Terms and Conditions of such Admissions. Additional Members may be admitted upon the approval of a majority of the Members of the Company, upon the written application of such new Member, in the manner set forth in the Operating Agreement of this Company.

Each person who is or was a Member or Manager of the Company (and the heirs, executors, personal representatives, administrators, or successors of such person) who was or is made a party to, or is involved in any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative, or investigative, by reason of the fact that such person is or was a Member or Manager of the Company or is or was serving at the request of the Company as a Member or Manager, director, officer, partner, trustee, employee or agent of another limited liability company, corporation, partnership, joint venture, trust, employee benefit plan or other enterprise ("Indemnitee"), shall be indemnified and held harmless by the Company to the fullest extent permitted by applicable law, as the same exists or may hereafter be amended.
