Address

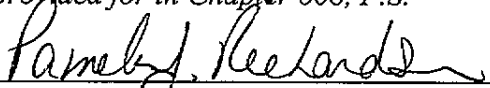

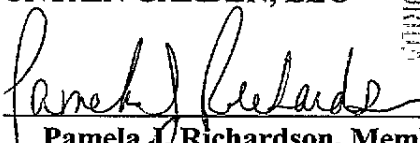
ARTICLE SIX
