ARTICLES OF ORGANIZATION OF
COPPER MOUNTAIN VACATION RENTALS, L.L.C.
A FLORIDA LIMITED LIABILITY COMPANY

THE UNDERSIGNED, SCOTT K. HARRISON, constituting all the voting members of COPPER MOUNTAIN VACATION RENTALS, L.L.C. (the "Limited Liability Company") pursuant to Florida Statute 608.407 does hereby execute these Articles of Organization of COPPER MOUNTAIN VACATION RENTALS, L.L.C. for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act and does hereby state and set forth:

1. The name of the Limited Liability Company is COPPER MOUNTAIN VACATION RENTALS, L.L.C.
2. The period of duration of COPPER MOUNTAIN VACATION RENTALS, L.L.C. shall be perpetual.
3. The mailing address and street address of the principal office of the Limited Liability Company 2901 N.E. 22nd Court, Pompano Beach, Florida 33062.
4. The name of the initial registered agent in Florida for the Limited Liability Company is SCOTT K. HARRISON and his street address is 2901 N.E. 22nd Court, Pompano Beach, Florida 33062. The acceptance of SCOTT K. HARRISON as registered agent appears after the execution of these Articles of Organization below.
5. No members shall be allowed to admit additional members except by a unanimous vote of the voting members of the Limited Liability Company, or upon such other vote as may be prescribed by the Limited Liability Company regulations.
6. If the Limited Liability Company has more than one member, the Limited Liability Company shall not dissolve and the remaining members of the Limited Liability Company shall continue its business upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Limited Liability Company.
7. The management of the Limited Liability Company is reserved to its voting members. The names and addresses of the voting members of the Limited Liability Company are:
 - a. SCOTT K. HARRISON, 2901 N.E. 22nd Court, Pompano Beach, Florida 33062.
8. All other matters regarding the relative rights of the voting and non-voting members of the Limited Liability Company, and the operations of the Limited Liability Company

shall be determined by the Limited Liability Company regulations. The power to adopt, alter, amend, or repeal the regulations of the Limited Liability Company shall be vested in the voting members of the Limited Liability Company.
