ARTICLES OF ORGANIZATION OF COPPER MOUNTAIN VACATION RENTALS, L.L.C. A FLORIDA LIMITED LIABILITY COMPANY

THE UNDERSIGNED, SCOTT K. HARRISON, constituting all the voting members of COPPER MOUNTAIN VACATION RENTALS, L.L.C. (the "Limited Liability Company") pursuant to Florida Statute 608.407 does hereby execute these Articles of Organization of COPPER MOUNTAIN VACATION RENTALS, L.L.C. for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act and does hereby state and set forth:

If the Limited Liability Company has more than one member, the Limited Liability Company shall not dissolve and the remaining members of the Limited Liability Company shall continue its business upon the death, retirement essignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Limited Liability Company.
