**ARTICLES OF ORGANIZATION
OF
SPAVE, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization of SPAVE, LLC.

The mailing address and street address of the principal office of the company is: 13176 N. Dale Mabry, No. 157, Tampa, Florida, 33618.

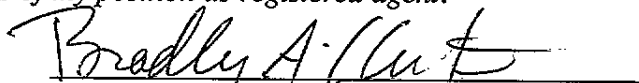
ARTICLE III -- DURATION

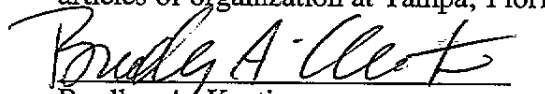
