ARTICLES OF ORGANIZATION OF DENTEL CARS II, LLC, A FLORIDA LIMITED LIABILITY COMPANY



ARTICLE I NAME

The name of this Limited Liability Company shall be DENTEL CARS II, LLC, and its principal place of business shall be located at 2637 Aurora Road, Melbourne, Florida 32935.

ARTICLE II COMMENCEMENT OF CORPORATE EXISTENCE

The headings or captions of these various Articles of Organization are inserted for convenience and none of them shall have any force or effect, and the interpretation of the various Articles shall not be influenced by any of said headings or captions.
