**ARTICLE I — Name:**

The name of the limited liability company (hereinafter referred to as the "Company") is Walsh, LLC

**ARTICLE II — Address:**

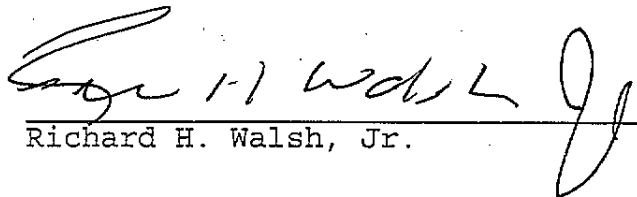
