

ARTICLES OF ORGANIZATION

J & K PRICE#6, LLC


A LIMITED LIABILITY COMPANY


(Pursuant to s. 607.407, Florida Statutes)

1. Name. The name of the limited liability company is J & K PRICE#6, LLC.
2. Purpose. The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.


