

OF

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I — Name:

The name of the limited liability company (hereinafter referred to as the "Company") is "Alpha Growers, LLC"

ARTICLE II — Address:

ARTICLE III — Duration:

The period of duration for the Company shall be perpetual.

ARTICLE VI — Members' Rights to Continue Business:


