We have been retained by the above referenced taxpayer recently as its CPA Firm.

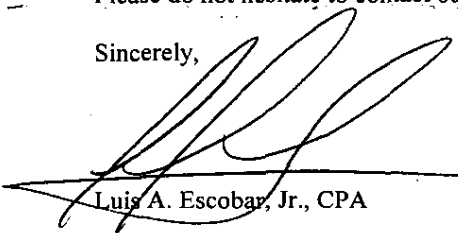
