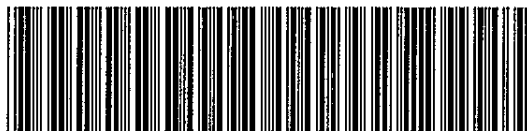

**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION

**ARTICLE I**

Articles of Organization for DUKE-SOUTHCENTER II, L.L.C. (the "Company") were filed with the Florida Department of State on May 17, 2002, and assigned document number L02000012088.

**ARTICLE II**


The following amendment to the Articles of Organization were adopted by the Company:


