**ARTICLE I - Name:**


**ARTICLE VII - Members Rights to Continue Business:**

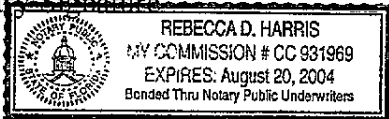


