ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF

MIGUEL A MONTEJO, M.D, LLC

FIRST: The date of filing of the Articles of Organization was May 13, 2002.

SECOND: The following amendments to the Articles of Organization were adopted by the limited liability company:

A. All references to limited liability company, as contained in the Articles of Organization filed on May 13, 2002, are and all such references are hereby amended in their entirety to read and reference: "Professional Limited Liability Company" and that such entity was formed pursuant to Chapter 621, Florida Statutes, also known as the Florida Service Corporation and Professional Limited Liability Act, and was not formed pursuant to Chapter 608, Florida Statutes, also known as the Florida Service Corporation and Professional Limited Liability Company Act.

B. The introductory paragraph of the Articles of Organization is hereby revised to read as follows:

"The name of this Limited Liability Company is MIGUEL A. MONTEJO, M.D., PLC."

C. Article IV - PURPOSES AND POWERS, is hereby amended to read and reference the following:

ARTICLE IV. PURPOSE AND NATURE OF BUSINESS

1. To engage in the practice of anesthesiology and to render such services as may be ancillary to the foregoing. The Company may purchase and own real and personal property necessary or appropriate for rendering its professional services and may invest its funds in real estate, mortgages, stocks, bonds and any other type of investments, all in accordance with the provisions of Chapter 621 of the Florida Statutes.

2. To own property, enter into contacts and carry on any activity necessary or incidental to the accomplishment or furtherance of the purpose of this Company.

3. The services of this Company which consist of the practice of anesthesiology shall be carried out only through officers, employees and agents who are in good standing and licensed in Florida to render anesthesiology physician services by the Florida Department of Professional Regulation, or any other state board or agency which regulates anesthesiology physicians.

4. To do everything necessary, proper or convenient for the accomplishment of any of the purposes herein set forth, and to do every other act incidental thereto which is not forbidden by the laws of the State of Florida, by the Rules of the Department of Professional Regulation or by the provisions of these Articles of Organization.
