**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF
MORE INVESTMENTS L.L.C.
TO CHANGE NAME OF THE COMPANY TO
MORE REALTY INVESTMENTS L.L.C.**

Pursuant to the provisions of Section 608.411 of the Florida Limited Liability Company Act, the undersigned Limited Liability Company adopts the following Articles of Amendment to its Articles of Organization:

1. The current name of the limited liability company is More Investments L.L.C., and the date of filing of the Articles of Organization was May 20, 2002.
2. This Amendment to the Articles of Organization was adopted on July 2, 2002 unanimously by written consent of all of the Managers and the Members of the Company holding one hundred percent (100%) of the membership interest in the Company, pursuant to the provisions of Chapter 608 of the Florida Limited Liability Company Act and the Operating Agreement of the Limited Liability Company.
