THE UNDERSIGNED, SCOTT M. SCHWARTZ and ADAM L. MENKES, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME AND PRINCIPAL OFFICE

The name of the limited liability company shall be EXXACT DATA, LLC, ("Company"). The principal office of the Company in Florida shall be: 8695 College Parkway, Suite 327, Fort Myers, Florida 33919.
