The Articles of Organization following are adopted for the purpose of organizing a Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes.

ARTICLE I

Name and Address of Company

The name of the limited liability company ("Company") is AgriCycle Alliance, LLC. The Company's street address is Highway 19 South, Monticello FL 32344, and its mailing address is P. O. Box 993, Monticello FL 32345.

ARTICLE II

Commencement and Duration of Company

The Company shall exist from the date of filing these Articles with the Florida Department of State until the occurrence of any of the events specified in Section 608.441, unless continued by the unanimous consent of all of the remaining members.

ARTICLE III

Management

The following person shall serve as the Company's initial manager until the first annual meeting of the membership or until his successor is elected and qualified: Thad Beshears, Route 4 - Box 4188, Monticello FL 32344. Thereafter, the Company will be managed by a manager or managers elected annually, as provided in the Company's regulations.

ARTICLE IV

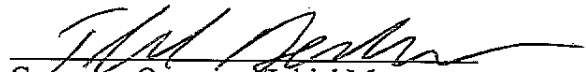
Admission of Additional Members
